### A. COSM 1545 Clinical I: Advanced Practice Esthetics

### B. COURSE DESCRIPTION:

This practical application course includes specific client services. Under instructor supervision, students will provide previously learned advanced facial services to clients, mannequins, and classmates. Salon safety, sanitation, and infection control are stressed. Students experience salon reception and dispensary service work. Satisfactorily completed quotas accumulate to meet quota requirements.
