B. COURSE DESCRIPTION:

This course provides the opportunity to complete the required quotas necessary to perform practical skills testing. Students perform services on clients, other students, and mannequins. These services accumulate to meet quota completion and minimum hourly requirements for Minnesota licensure. Prerequisites: COSM 1100, COSM 1105, and COSM1110.

<u>CS</u>	understand the importance of the duties required in operation of the dispensary.	1. perform duties required for successful operation of the dispensary. 2. complete a daily checklist while in the dispensary.
<u>CS</u>	understand receptionist duties.	1. perform receptionist duties. 2. complete a daily checklist while working at the reception desk.
