B. COURSE DESCRIPTION:

This course provides the opportunity to complete the required quotas necessary to perform practical skills testing. Students perform services on clients, other students, and mannequins. These services accumulate to meet quota completion and minimum hourly requirements for Minnesota licensure. Prerequisites: COSM1100, COSM1105, COSM1110, 1115 and 1125.

<u>CS</u>	understand receptionist duties.	1. perform receptionist duties. 2. complete a daily checklist while working at the reception desk.
